MIGRATION ACT 1958 SECTION 147 - ISSUE OF  
COMMONWEALTH CRIMINAL JUSTICE STAY CERTIFICATE

WHEREAS Mohamed HANEEF (also known as ATHAN), a citizen of India, born on  
29 September 1979, is an unlawful non-citizen for the purposes of the *Migration Act 1958*  
(the Act);

AND WHEREAS Mohamed HANEEF (also known as ATHAN) is to be, or is likely to be,  
removed or deported from Australia;

AND WHEREAS I consider that Mohamed HANEEF (also known as ATHAN) should  
remain in Australia temporarily for the purposes of the administration of criminal justice in  
relation to an offence against a law of the Commonwealth;

AND WHEREAS I consider that satisfactory arrangements have been made to ensure that  
the costs of keeping Mohamed HANEEF (also known as ATHAN) in Australia will be met  
by the Australian Federal Police;

NOW THEREFORE I, Philip Maxwell Ruddock, Attorney-General of the Commonwealth  
of Australia, hereby certify that the day of the removal or deportation of Mohamed  
HANEEF (also known as ATHAN) from Australia is required for the administration of  
criminal justice
